REBATE GUIDELINES

HBO[®] services must be distributed in your property at the time of submission. A property that carried HBO and switched to a different distributor or chain affiliation is not considered a launch.

To redeem your rebate, a fully executed video distribution services contract, including property name, address, city, state, zip code and minimum 5-year term must be provided for the \$9.00 per room rebate or minimum 3-year term for \$7.00 per room rebate. Carriage obligation for HBO must be expressly required throughout the term of the contract. Contracts need to be executed between January 2017 and December 2017 to apply. No prior contracts will be accepted.

As not all providers are authorized for this program, confirm participation with associated distributor prior to submission.

HBO must be distributed in 100% of all units to qualify.

This incentive applies to hotel franchised properties & non-hospitality bulk MDU properties only.

Please keep a copy for your files and allow 6-8 weeks for delivery of your check. **Check will be sent to the address on your W-9 form.**

HOW TO SUBMIT

Deadlines:

All rebate requests for contracts executed and that have begun billing between January 1 - June 30, 2017, must be submitted by July 31, 2017.

All rebate requests for contracts executed and that have begun billing between July 1 - December 31, 2017, must be submitted by January 5, 2018.

Contracts must be for service commencing between January 1, 2017 and December 31, 2017 and clearly state HBO as a premium offering.
